Sub: Summary of Order-in-Original No. 03/DIR/FIU-IND/2024 in the matter of

Shri Patneshwar Urban Co-operative Bank Ltd. reg.

The RBI shared the findings of its inspection report in respect of <u>Shri Patneshwar</u> <u>Urban</u> Co-operative Bank Ltd. (the Bank) with FIU-IND pertaining to its failure to file Cash Transaction Reports (CTRs) and failure to file Suspicious Transactions Reports (STRs) and for its failure to evolve an effective internal mechanism to detect and report Suspicious Transactions in terms of the provisions of the PML Act and the PML Rules.

2. Vide Show Cause Notice dated August 22, 2016, the Bank was called upon as to why action should not be taken against the Bank under Section 13 of the Act read with Section 12 of the Act and rule rules 3, 5 and 7 of the Rules, 2005 for non-compliance as enumerated in para 1 above.

3. The Bank submitted its reply to the SCN and in compliance of the Principles of Natural Justice, the Bank was granted opportunity of Personal Hearing (PH) through its Authorised Representatives (ARs).

4. After considering the submissions of the Bank including the details of the corrective steps taken, the Director, FIU-IND disposed of the adjudication proceedings initiated against the Bank and the charges have been dropped.
