Retired Government officials who have not attained the age of 62 years on last date of receipt of the application can apply.

#### 7. **Duration**:

Candidates selected will be appointed on contract basis for a period of six months or till or till one of the two vacant posts of Section Officer is filled up on a regular basis, whichever is earlier.

# 8. **Method of Selection:**

The shortlisted candidates will be interviewed by a Selection Committee constituted for this purpose, whose decision will be final and no correspondence in this regard will be entertained. Intimation shall be sent only to the selected candidate. FIU-IND would undertake police verification of the selected candidates.

#### 9. **Undertaking:**

## **TERMS AND CONDITIONS:**

- 1. Retired Government employees with relevant experience would be eligible for selection.
- 2. The appointment of Consultant would be on Full time basis and they would not be permitted to take up any other assignment during the period of Consultancy with FIU-IND.
- 3. Consultant would be required to sign a Non Disclosure Undertaking as per Annexure-II.
- 4. The Consultant shall not indulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements, and administrative / organizational matters as all are of confidential / secret nature.
- 5. The appointment of Consultant is of a temporary (non official) nature and the appointment can be cancelled at any time without assigning any reason.
- 6. A retired Government official appointed as Consultant shall continue to draw pension and the dearness relief on pension during the period of his engagement as Section Officer. His / her engagement shall not be considered as a case of re-employment.
- 7. The Consultant shall not be entitled to any allowance such as Dearness allowance, Residential Telephone, Transport Facility, Residential Accommodation, Personal Staff, CGHS, Medical Reimbursement etc.
