

3. After inspection of the items, intended bidders may submit quotations as per proforma at Annexure-I and Annexure-II. Sealed tender may be superscribed :Tender for obsolete/unserviceable articles" may be addressed to Deputy Director (Admn), FIU-IND, 6th Floor, Tower 2, Jeevan Bharti Building, Connaught Circus, New Delhi-110001 **by 26th December, 2020 on or before 11:00 A.M.**
4. **The bids of only those firms will be entertained who physically inspected the items before submitting of the bids.** Bidders will submit "Bid Security Declaration" duly signed stating that 'if they withdraw or modify their bids during period of validity etc, bidder will be suspended for a period of three months from the last date of submitting the bid from the time specified in the tender documents. The quotations without bid declaration will not be entertained.
5. The quotations will be opened on the next day of the closing date of the submission the bids, by an Evaluation Committee of the FIU-IND in the presence of such tenders willing to be present in Deputy Director (Admn), FIU-IND, 6th Floor, Tower 2, Jeevan Bharti Building, Connaught Circus, New Delhi-110001. The bids will be examined on the basis of Technical Specification of the firms and rates quoted by them.
